**PROPOSALS TO (i) ESTABLISH A 6<sup>th</sup> FORM CENTRE FOR TORFAEN AND (ii) MAKE A REGULATED ALTERATION TO CROESYCEILIOG SCHOOL, CWMBRAN HIGH SCHOOL AND ST ALBAN'S RC HIGH SCHOOL BY ENDING SIXTH FORM PROVISION**

The consultation period in respect of the above mentioned proposals closed on Friday 23<sup>rd</sup> December 2016. In accordance with the Welsh Government School Organisation Code, the Authority must within 13 weeks of the end of this period (in this instance by 24<sup>th</sup> March 2017) allowed for responses (and in any event prior to publication of proposals) publish a consultation report which:

- Summarises each of the issues raised by consultees;
- Responds to these by means of clarification, amendment to the proposal or rejection of the concerns, with supporting reasons; and
- Sets out Estyn's view (as provided in its consultation response) of the overall merits of the proposal.


